**Safe, Healthy Communities** – Does the nominee's work generate community pride? Does the work enhance neighborhood appearance? Does the work decrease blight and vacancy? Does the work improve access to education, healthy lifestyle alternatives, etc.?

**Financial Stability**—does the nominee's work provide employment and/or income opportunities for neighborhood residents? Does the work promote family financial stability, improve incomes and provide opportunities for families to invest in home ownership (assets)?

## **Community Development Awards Winners 2016 - 2022**

#### JF Bryan Award (Formerly known as EPIC Award)

**2016 – Edward Waters College** for providing leadership and resources for the revitalization of the New Town Neighborhood and Kings Road Commercial Corridor.

**2018 – Northwest Jacksonville Community Development Corporation** for enhancing community and incorporating two or more of the five pillars of LISC's Building Sustainable Communities

model. Northwest Jacksonville CDC provided leadership and resources for the revitalization of several neighborhoods within the Northwest Jacksonville geographic area.

**2020 – Northwest Jacksonville Community Development Corporation** for an open-air farmers market on Northpoint II property which is located in a food desert.

**2022** - **Kingdom Plaza Mall** The visionary leadership of Bishop Vaughn and Narlene McLaughlin has created a ministry that is socially, economically, educationally, and spiritually uplifting the lives of many in the Westside Normandy Village community.

#### Janet Owens Award (Formerly known as Igniter Award)

**2016 – Delores Barr Weaver** for pioneering the revitalization of a Northwest Riverside Neighborhood through the condominium-conversion of john Gorrie Middle School

**2018 – John Crispins** for serving as a catalyst for commercial corridor revitalization in Springfield through the establishment of Crispy's Restaurant in the historic Akra Department Store Building inspiring others to follow.

#### 2020 – Hope McMath

**2022** - Joyce Delifus, the founder of the Shawn D. Delifus Foundation named in honor of her late son, embodies safety, justice, and positive community engagement through her work by providing swimming lessons to children and connecting children and senior adults with personal growth and development opportunities.

#### Igniter Award (Formerly known as Building Blocks Award)

**2016 – First Coast YMCA** for development and building the Winston Family YMCA as a central component of the revitalization of Jacksonville's Brooklyn Neighborhood.

**2018** – **Ben Davis** Intuition Ale Works, for advancing the city's urban Doro Neighborhood through the establishment of Intuition Ale Works Brewery and Tap Room as a cornerstone of the neighborhood adjacent the arena, stadium and the baseball field.

2020 - Vestcor for development of workforce housing with easy access to transportation in LaVilla.

**2022-** Iben Lakay, LLC Entrepreneur James Smith purchased and rehabilitated a nearly 4,000-square-feet commercial property situated in Springfield. The property, which was a vision and pioneering project by the owner to help revitalize Main Street into a thriving commercial corridor.

#### **Honorary Award**

**2022** - Presented to Michelle Braun for her dedicated service not only as serving LISC Jacksonville Local Advisory Committee for more than 15 years but also President & CEO of United Way of Northeast Florida from 2014 to 2022.

#### **Other Past Winners/Awards**

#### **Champion of Main Street**

Recognizes an outstanding individual or organization that has provided advocacy, leadership, and innovation in helping to strengthen Jacksonville's urban core communities.

2016 – Black Sheep Restaurant Group for serving as a catalytic force in the revitalization of the 5-Points Neighborhood.
2018 – Springfield Preservation and Revitalization Council for providing advocacy and leadership in strengthening Jacksonville's urban core communities, focusing on reviving commercial activity along Main Street in Springfield.
2020 – VyStar Credit Union for renovation of American Heritage Life Tower bringing 800 employees to downtown Jacksonville.

#### Power of Community Award (Collective Impact)

Recognizes individuals, for-profit and not-for-profit businesses, and/or government agencies that have provided collaboration and leadership in bringing together diverse voices to improve the community through targeted programs, initiatives or physical development.

**2016 – Mayor Lenny Curry, Councilman Garret Dennis, and the Eureka Gardens Tenant Association,** for transforming the living conditions for more than 800 residents.

2018 – The Rail Yard District Reenergize Jacksonville's Rail Yard District. The 300 + businesses in the district employ over 6,000 community residents and bring over \$2.6 billion dollars in revenue to the city.
