May 21st will always be a memorable day for me as this was my first day as an Oramenta Newsome Community Development fellow at the Anacostia Business Improvement District (ABID). Before visiting Southeast Washington, DC, specifically Anacostia in Ward 8, I had heard many negative stereotypes about the area. However, my perspective changed when I walked into Paola's for a sandwich. A man passed by with his pregnant dog and stopped to inform the lady at the counter that the dog was almost due and that he would let her know when she could get a puppy. This simple, neighborly interaction reminded me of Nairobi, Kenya, where I am from, and I instantly knew I would love Anacostia.

During my assignment to the Anacostia Business Improvement District (BID), I contributed to efforts addressing the unique challenges of this historically underserved area. Despite facing economic and social obstacles, Ward 8 boasts a rich cultural heritage. The Anacostia BID has successfully supported local businesses and preserved the area's character, recognizing its potential for growth and transformation. This culminated in Mayor Muriel Bowser designating Ward 8 as DC's Arts & Culture District under the Art to Go-Go initiative on February 23, 2023. Additionally, I played a key role in convening stakeholders to drive the 295 underpass project, aiming to transform the space into a vibrant hub promoting public safety, emotional well-being, and community engagement.

Additionally, the role of the Local Initiatives Support Corporation (LISC) has been crucial in these efforts. As a Community Development Financial Institution (CDFI), LISC has championed this cause by partnering and providing funding for organizations like the Anacostia BID. They have also supported local organizations' capacity by providing summer fellows as a way to honor the late Oramenta Newsome. Acting as a liaison for small businesses and agencies, I served as a resource for diverse needs. The Anacostia Business Improvement District (BID) has been recognized for its dedication to promoting art in all forms, including the city's official music, go-go. Through innovative initiatives like Art to Go-Go, the BID has fostered inclusive economic growth, celebrating the community's culture and history. By supporting small businesses and artists, the BID has created a vibrant and welcoming environment. Specifically, Art to Go-Go empowered artists by providing resources

like materials and a platform to showcase and sell their work at the Giant BBQ, contributing to their economic success.
