The Lead Safe Hamilton County Program supports homeowners by reducing lead hazards. Eligible repairs are based on the condition and age of your property and may include new windows and doors, siding, interior and exterior painting, and repairs to fascia and soffits. These repairs all address common places where lead paint could chip or erode.

INSTRUCTIONS

The Lead Safe Hamilton County Program has a two-step application process. First, please complete all of the questions included in the Pre-Qualification Checklist. Working In Neighborhoods, the Program Intake Center partner, will review the Checklist to determine if you may be eligible for the Program. If they determine you may be eligible, you will then complete a full Application Packet.

- Completing the Pre-Qualification Checklist and Application Packet does not guarantee eligibility, participation, or funding.
- The condition of the home and the type of repairs needed are a factor in determining program eligibility.
